On April 1 2013, Jos Gielink CPL LLM established an independent pensions law firm, Gielink Pensioenrecht, specialising in the legal and tax aspects of pension arrangements.

Jos Gielink (1959) specialises in pensions law. In his professional practice, his primary field of activity relates to the tax and legal aspects of pension schemes. He advises large and medium-sized employers, pension funds and insurance companies about pension schemes and insurance products. These matters can include international aspects and the corporate or wage tax aspects of pensions.

Jos worked as a tax advisor and pension lawyer from 1985 until 2005 with Loyens & Loeff. In 2005 he was one of the founders of Bergamin & Gielink Pensioenrechtadvies, where he was a director and coowner until 2013.

Jos graduated cum laude from the Faculty of Law of Tilburg University. In 2004 he completed the postgraduate course in pension law at VU University Amsterdam (CPL Certified Pension Lawyer). In 2013 he successfully completed the pension insurance course.

Jos has been a lecturer on international pension taxation for the Adv LLM course at the International Tax Center Leiden since 2004.

In addition, he was a board member of the pensions practice group at Loyens & Loeff and co-chair of the international practice group on pensions of Ius Laboris, a worldwide international alliance of employment and pensions law specialists.

Jos is a member of various associations of pension specialists. He is the editor of two Dutch pension magazines, regularly publishes articles on the subject of pensions and gives lectures on this topic.
